At all times mentioned, in the City of Yucaipa, County of Riverside, you, CHANA GARCIA, acted as a real estate broker performing residential resales and property management activities pursuant to Code Sections 10131(a) and 10131(b) respectively.

On April 27, 2007, the Department completed an audit examination of your books and records, CHANA GARCIA, pertaining to your property management activities described in Paragraph 3, that require a real estate license. The audit examination covered a period of time beginning on January 1, 2006 to January 31, 2007.
