

On or about July 18, 2007, as a result of the Decision in case No. H-33032 LA, Marvin Earl Catchings had his broker license revoked with the right to a restricted broker license.

III

The matter alleged in Paragraph II is grounds to deny Respondent's application under Section 10177(f) of the California Business and Professions Code.

The Statement of Issues is brought under the provisions of Section 10100, Division 4 of the Business and Professions Code of the State of California and Sections 11500 through 11528 of the Government Code.

contained herein, that the Commissioner refuse to authorize the
issuance of, and deny the issuance of, a real estate broker
license to Respondent, GREAT WESTERN LENDING GROUP, INC. with
