You, LUPE DOMINGUEZ, are licensed by the Department of Real Estate of the State of California ("Department") as a real estate salesperson, employed by Charles Neighbors. You are not now and have never been licensed by the Department as a real estate broker.

You, CLEO CIBRIAN, are not now and have never been licensed by the Department as a real estate broker.

3.

You, PROFESSIONAL FILING SERVICES INC., are not now and have never been licensed by the Department as a real estate broker.

4.

You, LUPE DOMINGUEZ INC., are not now and have never been licensed by the Department as a real estate broker.

5.

During a period of time from on or before October 15, 2008, and continuing to the present time, you, LUPE DOMINGUEZ, you, CLEO CIBRIAN, you, LUPE DOMINGUEZ INC., and you, PROFESSIONAL FILING SERVICES INC., acted in the capacity of, advertised or assumed to act as real estate brokers in the State of California, within the meaning of Code Sections 10131(d) and 10131.2, for or in expectation of compensation.

1 Your activities included the operation of or conduct of a real
2 property sales business with the public wherein you engaged in
3 the negotiation and solicitation of borrowers and lenders for
4 loans secured by residential real property. Said activities

26 above, are acts requiring a real estate broker license under
27 the provisions of Code Sections 10131(d) and 10131.2.


You, LUPE DOMINGUEZ, you, CLEO CIBRIAN, you, LUPE DOMINGUEZ INC., and you, PROFESSIONAL FILING SERVICES INC., violated Code Section 10130 by engaging in the activities described in Paragraphs 5, 6 and 7 above, without first obtaining a real estate broker license from the Department.

NOW, THEREFORE, YOU, LUPE DOMINGUEZ, YOU, CLEO CIBRIAN, YOU, LUPE DOMINGUEZ INC., AND YOU, PROFESSIONAL FILING SERVICES INC., ARE ORDERED TO DESIST AND REFRAIN from performing any and all acts within the State of California for which a real estate broker license is required, within the meaning of Code Sections 10131(d) and 10131.2, unless and until you obtain a real estate broker license or a real estate salesperson license and are employed by a real estate broker.
