Said crime 17 involves moral turpitude and bears a substantial relationship 18 under Section 2910, Title 10, Chapter 6, California Code of 19 Regulations, to the qualifications, functions or duties of a real 20 estate licensee. 21

The felony conviction of Respondent CCREI's designated broker-officer Allan Berlin Steward, constitutes cause under Code Sections 490 and 10177(b) for the suspension or revocation of all licenses and license rights of Respondent under the Real Estate Law.
