

> ORDER TO DESIST AND REFRAIN

NO. H-35797

The Real Estate Commissioner of the State of California (hereinafter "Commissioner") has caused an investigation to be made of your activities and, based upon the findings herein below set forth, is of the opinion that you, NATIONAL FUNDING, LLC, doing business as Loan Modification Group, National Loan Modification Group, have violated Section 10130 of the California Business and Professions Code (hereinafter the "Code") by engaging in the business of or acting as a real estate broker, within the meaning of Sections 10131(d) and 10131.2 of the Code without first having obtained a real estate broker license from

the California Department of Real Estate (hereinafter the "Department").

1.

At no time herein mentioned were you, NATIONAL FUNDING, LLC, doing business as Loan Modification Group, National Loan Modification Group, licensed by Department as a real estate broker.

2.

During the period beginning in or about July 2008 and continuing, you, NATIONAL FUNDING, LLC, doing business as Loan Modification Group, National Loan Modification Group, among other things, solicited and/or performed services for borrowers, in connection with loans secured directly or collaterally by liens on real property or on a business opportunity, for or in expectation of a compensation, including a fee received in advance.

You, NATIONAL FUNDING, LLC, doing business as Loan Modification Group, National Loan Modification Group, for or in expectation of compensation, described in Paragraph 2 above performed acts requiring a real estate broker license under the provisions of Section 10131(d) and 10131.2 of the Code.

You, NATIONAL FUNDING, LLC, doing business as Loan Modification Group, National Loan Modification Group, violated Section 10130 of the Code by engaging in the activities described above in Paragraph 2 without first obtaining a real estate salesperson or broker license from the Department.
