ARROYO, and you, ANTONIO ANGULO, engaged in the business of, acted in the capacity of, or advertised a loan modification service and advance fee brokerage using the name Wall Street Financial LLC offering and performing loan modification services with respect to loans which were secured by liens on real property for compensation or in expectation of compensation and for fees often collected in advance as well as at the conclusion of the transaction. You contacted lenders on behalf of distressed homeowners seeking modification of the terms of their home

loans, principal reduction, foreclosure abatement, loan refinance, and/or short sale services and advice.

Your acts, WALL STREET FINANCIAL LLC, RASHA REYN,

3, above, are acts requiring a real estate broker license under

Oliveros signed two loan modification agreements, a Mortgage Loan Modification Service and a Principal Reduction Service and said paid \$1,900, to WALL STREET FINANCIAL LLC, at MARIA E. ARROYO's recommendation and by and through MARIA E. ARROYO.
