

10130 of the Business and Professions Code (hereinafter "Code")
by engaging in the business of a real estate broker within the

You, GREGORY COLE and MARIA ELENA LOCSIN, are not now and have never been licensed by the Department of Real Estate of the State of California ("Department") as a real estate broker. At all times material herein, you, GREGORY COLE were and are doing business as Adiem Consultants, a business entity not licensed by the Department.

At all times material herein, you, GREGORY COLE, were licensed and/or have license rights under the Code as a real estate salesperson, not acting in the employ of a real estate broker.

At all times material herein, you, MARIA ELENA LOCSIN, were licensed and/or have license rights under the Code as a real estate salesperson acting in the employ of Jon Paul Bourgault, a licensed real estate broker.

All further references to "you" include the parties identified in Paragraph 1, above, and also include the officers, directors, employees, agents and real estate licensees employed by or associated with said parties and who at all times herein mentioned were engaged in the furtherance of the business or operations of said parties and who were acting within the course and scope of their authority and employment.

During a period of time from September 15, 2008 and continuing through to the present time, you, GREGORY COLE, and you, MARIA ELENA LOCSIN, without your employing broker's knowledge, have engaged in the business of, acted in the capacity of, or advertised a loan modification service and advance fee brokerage using the name Adiem Consultants, offering and performing loan modification services with respect to loans which were secured by liens on real property for compensation or in expectation of compensation and for fees often collected in advance as well as at the conclusion of the transaction. You offered to or contacted lenders on behalf of distressed homeowners seeking modification of the terms of their home loans, principal reduction, foreclosure abatement, loan refinance, and/or short sale services and advice.
