During the course of representing the borrowers, 4 Respondents' agent, Wally Fogar, made material misrepresentations 5 regarding the terms and conditions of the loans, and failed to 6 explain that there would be two loans (not one), that the loans 7 would be adjustable and variable rates and would not be fixed 8 rates, and that, as a result, payment amounts would fluctuate 9 . 10 upwards during the life of the loan.

Respondents, doing business as "Elite Financial Home Loans," were compensated for their services brokering the loans to the borrowers. Compensation included a \$7,700.00 loan origination fee, a yield spread premium from the lender paid -16 outside of escrow of \$12,512.50, and a yield spread premium from the lender paid outside of escrow of \$1,650.00, for a total of \$21,862.50.

During the time that Respondents represented the 21 borrowers in the subject loan transaction, ALWAYS HERE's 22 corporate status was suspended and it was not a corporation in 23 good standing with the Secretary of State. Respondent ARIAS 24 25 failed to ensure that Respondent ALWAYS HERE and its employees 26 and agents performed real estate activities in compliance with 27 the Real Estate Law.

1 On or about October 15, 2008, the Department served a 2 subpoena duces tecum requesting that Respondents produce the 3 transaction records pertaining to the above referenced 4 In response to the subpoena, Respondent ARIAS transaction. 5 informed the Department that she was not able to locate the file 6 and therefore was not able to produce it for the Department's 7 8 review. 9 13.
