2 During a period of time, in or about the last three
3 years, you engaged in the business of, acted in the capacity of,
4 advertised or assumed to act as a real estate broker in the
5 State of California, for another or others, including but not
6 necessarily limited to William Mewsel, within the meaning of
7 Code Section 10131(a) for or in expectation of compensation.
8 Your activities included, but were not necessarily limited to,
9 holding yourself out to the public or otherwise representing
10 that you were a licensed real estate broker, wherein you engaged
11 in the conduct of selling, offering to sell, soliciting
12 prospective purchasers of, obtaining listings of, or negotiating
13 the purchase, sale or exchange of real property or a business
14 opportunity.

16 Your acts as described in Paragraph II, above, are
17 acts requiring a real estate broker license under the provision
18 of Code Section 10131(a).

19 IV

20 You violated Code Section 10130 by engaging in the
21 activities described in Paragraph II, above, without first
22 obtaining a real estate broker license from the Department.



12 **Notice:** Business and Professions Code Section 10139 provides
13 that "Any person acting as a real estate broker or real estate
14 salesperson without a license or who advertises using words
15 indicating that he or she is a real estate broker without being
16 so licensed shall be guilty of a public offense punishable by a
17 fine not exceeding twenty thousand dollars (\$20,000), or by
18 imprisonment in the county jail for a term not to exceed six
19 months, or by both fine and imprisonment; or if a corporation,
20 be punished by a fine not exceeding sixty thousand dollars
21 (\$60,000)."
