It is hereby stipulated by and between MARIE LOUISE LO (hereinafter "Respondent") and Respondent's attorney, Mary E. Work, and the Complainant, acting by and through Lissete Garcia, Counsel for the Department of Real Estate, as follows for the purpose of settling and disposing of the Statement of Issues filed on September 1, 2009, in this matter:

Respondent acknowledges that Respondent has received and read the Statement of Issues and the Statement to Respondent filed by the Department of Real Estate in connection with Respondent's application for a real estate salesperson license. Respondent understands that the Real Estate Commissioner may hold a hearing on this Statement of Issues for the purpose of requiring further proof of Respondent's honesty and truthfulness and to prove other allegations therein, or that he may in his discretion waive the hearing and grant Respondent a restricted real estate salesperson license based upon this Stipulation and Waiver. Respondent also understands that by filing the Statement of Issues in this matter the Real Estate Commissioner is shifting the burden to Respondent to make a satisfactory showing that Respondent meets all the requirements for issuance of a real estate salesperson license. Respondent further understands that by

entering into this stipulation and waiver, Respondent will be stipulating that the Real Estate Commissioner 1 has found that Respondent has failed to make such a showing, thereby justifying the denial of the issuance 2 to Respondent of an unrestricted real estate salesperson license. 3 Respondent hereby admits that the allegations of the Statement of Issues filed against Respondent are 4 true and correct and requests that the Real Estate Commissioner in his discretion issue a restricted real 5 estate salesperson license to Respondent under the authority of Section 10156.5 of the Business and 6 Professions Code. 7 Respondent is aware that by signing this Stipulation and Waiver, Respondent is waiving Respondent's 8 right to a hearing and the opportunity to present evidence at the hearing to establish Respondent's 9 rehabilitation in order to obtain an unrestricted real estate salesperson license if this Stipulation and Waiver 10 is accepted by the Real Estate Commissioner. However, Respondent is not waiving Respondent's right to a 11 hearing and to further proceedings to obtain a restricted or unrestricted license if this Stipulation and 12 Waiver is not accepted by the Commissioner. 13 Respondent further understands that the following conditions, limitations, and restrictions will attach 14 to a restricted license issued by the Department of Real Estate pursuant hereto: 15 The license shall not confer any property right in the privileges to be exercised including the 16 right of renewal, and the Real Estate Commissioner may by appropriate order suspend the right 17 to exercise any privileges granted under this restricted license in the event of: 18 Respondent's conviction (including a plea of nolo contendere) of a crime which bears a 19 substantial relationship to Respondent's fitness or capacity as a real estate licensee; or 20 The receipt of evidence that Respondent has violated provisions of the California Real 21 Estate Law, the Subdivided Lands Law, Regulations of the Real Estate Commissioner or 22 23 conditions attaching to this restricted license. Respondent shall not be eligible to apply for the issuance of an unrestricted real estate license 24 nor the removal of any of the conditions, limitations, or restrictions attaching to the restricted 25 license until two years have elapsed from the date of issuance of the restricted license to 26 27 Respondent.

- 3. With the application for license, or with the application for transfer to a new employing broker,
 Respondent shall submit a statement signed by the prospective employing broker on a form
 approved by the Department of Real Estate wherein the employing broker shall certify as
 follows:
 - a. That broker has read the Statement of Issues which is the basis for the issuance of the restricted license; and
 - b. That broker will carefully review all transaction documents prepared by the restricted licensee and otherwise exercise close supervision over the licensee's performance of acts for which a license is required.
