ORDER SUSPENDING RESTRICTED REAL ESTATE LICENSE

On February 10, 2010, a Stipulation and Agreement was filed by the Bureau of Real Estate regarding the Accusation against RYAN MICHAEL DOLL, in Case No. H-36377 LA. Among the terms and conditions of this Stipulation and Agreement, which became effective on March 2, 2010, was an order that:

"Six months after the issuance of the restricted license, and at six month intervals thereafter during the term of any restricted license issued pursuant to this Decision, Respondent shall provide proof acceptable to the Real Estate Commissioner that, during the preceding six months, Respondent has, each and every week, attended

1 one or more sessions of Alcoholics Anonymous or similar Twelve Step or substance
2 abuse program, or that such attendance in any week was impractical due to travel for
3 work, the illness of Respondent or a member of Respondent's family, vacation,
4 incarceration, residential treatment for substance abuse, extreme personal hardship
5 for Respondent or a member of Respondent's family, or family emergency.
6 Respondent shall submit such proof to the Los Angeles Crisis Response Team
7 Manager of the Department of Real Estate."

8 The Commissioner has determined that, as of December 4, 2014,
9 Respondent has failed to satisfy this condition.

10 NOW, THEREFORE, IT IS ORDERED that the restricted real estate
11 salesperson license heretofore issued to Respondent RYAN MICHAEL DOLL and the
12 exercise of any privileges thereunder are hereby suspended until such time as Respondent
13 provides proof satisfactory to the Bureau of compliance with the condition(s) referred to
14 above.


15 IT IS FURTHER ORDERED that all license certificates and identification
