Based on the findings of that investigation, as set forth below, the Commissioner hereby issues the following 5 6 Findings of Fact and Desist and Refrain Order pursuant to 7 Section 10086 of the Code. 8 FINDINGS OF FACT 1. A&G is not now, and has never been, licensed by 9 10 the Department in any capacity. 2. 11 M&K is not now, and has never been, licensed by the Department in any capacity. 12 13 3. RAMIREZ is not now, and has never been, licensed 14 by the Department in any capacity. 4. BENGARD is not now, and has never been, licensed 15 by the Department in any capacity. 16 17 5. At the time set forth below each and every respondent solicited borrowers and negotiated to do one or more 18 of the following acts for another or others, for or in 19 expectation of compensation, engaged in the business of, acted 20 21 in the capacity of, or advertised a loan modification service and advance fee brokerage under one or more business names 22 including, but not limited to, "A&G Investments, A Real Estate 23 Company" and "M&K Financial Corporation" soliciting, offering to 24 25 negotiate or perform loan modification services with respect to loans which were secured by liens on real property for 26 compensation or in expectation of compensation and for fees 27

6. On or about August 15, 2008, RAMIREZ, on behalf
of A&G and M&K, solicited Maria Rico ("Rico") to negotiate a
short sale loan on real property located at 9635 Otis Street,
South Gate, CA 90280 ("the South Gate property"), for or in
expectation of compensation.

7. Beginning on or about October 17, 2008, RAMIREZ,
8 on behalf of A&G and M&K, provided an advance fee contract to
9 Rico for loan modification services on the South Gate property.

8. On or about October 17, 2008, RAMIREZ and
 BENGARD, on behalf of A&G and M&K, demanded and received an
 advance fee of \$2,500 from Rico for the activities described in
 paragraph 7, above.

9. On or about December 15, 2008, RAMIREZ and
BENGARD, on behalf of A&G and M&K, demanded and received an
additional advance fee of \$2,782.50 from Rico for the activities
described in paragraph 7, above.

## CONCLUSIONS OF LAW

20 10. Based on the information contained in Paragraphs 21 one through nine, above, A&G, M&K, RAMIREZ and BENGARD have performed and/or participated in acts, including loan 22 modification activities which require a license under the 23 provision of Code Sections 10131(d) and 10131.2 during a period 24 of time when A&G, M&K, RAMIREZ and BENGARD were not licensed by 25 the Department as a real estate broker, in violation of Code 26 27 Section 10130.
