21 Business and Professions Code (hereinafter "the Code"), you,  
22 Respondent, are hereby notified of the intention of the  
23 California Real Estate Commissioner (hereinafter "Commissioner")  
24 to issue a Bar Order pursuant to Section 10087(a) of the  
25 California Business and Professions Code.

1 Pursuant to the authority granted to the Commissioner  
2 by Section 10087 of the Code, and after review and consideration  
3 of:

4 1. The findings and Decision sustaining the  
5 allegations of the Accusation in Case No. H-2262 FR, as set  
6 forth in the Decision dated August 25, 2008, revoking  
7 Respondent's real estate license for violations of Sections  
8 10176(a) and 10176(i) and/or 10177(d), (h) and (j) of the Code.

9 The Commissioner finds that:

- 10 (A) A Bar Order is in the public interest;  
11 (B) Respondent has knowingly committed violations of  
12 the Real Estate Law; and,  
13 (C) Respondent's violations of the Real Estate Law  
14 have caused material damage to the public.

15 NOW, THEREFORE, IT IS ORDERED, pursuant to the  
16 authority of Section 10087 of the Code, you, THOMAS JOSEPH  
17 O'MEARA, be, and hereby are, barred and prohibited for a period  
18 of thirty-six (36) months from the effective date of this Bar  
19 Order, from engaging in any of the following activities in the  
20 State of California:

- 21 (A) Holding any position of employment, management,  
22 or control in a real estate business;  
23 (B) Participating in any business activity of a real  
24 estate salesperson or a real estate broker;  
25 (C) Engaging in any real estate related business  
26 activity on the premises where a real estate
