## CONCLUSIONS OF LAW

Based on the findings of fact set forth in 20 4. paragraphs 1 through 3, HERNANDEZ, acting by himself, or by 21 and/or through one or more agents, associates, affiliates, and/or 22 co-conspirators, solicited buyers and sellers and negotiated the 23 purchase and sale of real property and charged, demanded, or 24 collected advance fees for services provided, which are acts . 25 requiring a real estate broker license under Section 10131(a) and 26 10131.2 of the Code during a period of time when HERNANDEZ was 27



not licensed by the Department as a real estate broker in 1 violation of Code Section 10130. 2

## DESIST AND REFRAN ORDER

Based upon the Findings of Fact and Conclusions of Law stated herein, you, VICTOR HUGO HERNANDEZ, whether doing business 5 under your own name, or any other names, or fictitious name, ARE 6 ORDERED to immediately desist and refrain from performing any 7 acts within the State of California for which a real estate 8 9 broker license is required.

You are ORDERED TO DESIST AND REFRAIN from 10 charging, demanding, claiming, collecting and/or receiving 11 advance fees, as that term is defined in Section 10026 of the 12 13 Code.



Business and Professions Code Section 10139 provides 19 Notice: that "Any person acting as a real estate broker or real estate salesperson without a license or who advertises using the words 20 indicating that he or she is a real estate broker without being so licensed shall be guilty of a public offense punishable by a 21 fine not exceeding twenty thousand dollars (\$20,000), or by imprisonment in the county jail for a term not to exceed six 22 months, or by both fine and imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars 23 (\$60,000)." 24
