AND REFRAIN

The Real Estate Commissioner of the State of California (Commissioner) has caused an investigation to be conducted of your activities, as described herein, and based upon the findings of that investigation, is of the opinion that you, WILLIAM ANDREW BOHUSLAVIZKI, have violated Section 10130 of the California Business and Professions Code (Code).

The Purchase Agreement named you as the broker/associate licensee. As part of this transaction, you also requested cashier's checks to your name from the potential real estate purchasers for \$75,000 and \$55,000. The purchasers issued these checks on February 16, 2007 and February 26, 2007, respectively.

On or about February 22, 2007, you, WILLIAM ANDREW BOHUSLAVIZKI, signed a Residential Purchase Agreement and Joint Escrow Instructions for real property located at 5 Trumpet Vine, Mission Viejo, CA, 92624. The Purchase Agreement named you as the broker/associate licensee.

Your acts, as described in Paragraphs 2 and 3 above, violated Code Section 10130, within the meaning of Code Section 10131(a) by selling or offering to sell, buying or offering to buy, soliciting or obtaining listings of, or negotiating the purchase sale or exchange of real property or a business opportunity, when you were not licensed as a real estate broker or as a real estate salesperson working on behalf of a real estate broker.
