17	The Commissioner (Commissioner) of the California Department of Real Estate
18	(Department) caused an investigation to be made of the activities of WORLD FINANCIAL
19	INVESTMENTS CORP. (WORLD) and MICHAEL HABOUD (HABOUD). Based on that

investigation, the Commissioner has determined that WORLD and HABOUD have engaged in, 20 are engaging in, or are attempting to engage in, acts or practices constituting violations of the 21 California Business and Professions Code (Code) and/or Title 10, Chapter 6, California Code of 22 Regulations (Regulations), including the business of, acting in the capacity of, and/or advertising 23 or assuming to act as, real estate brokers in the State of California within the meaning of Section 24 10131(a) (selling or offering to sell or negotiating the purchase sale or exchange of real property) 25 and/or 10131(d) (soliciting, negotiating, or performing services in connection with loans) of the 26 Code. Furthermore, based on the investigation, the Commissioner hereby issues the following 27

Findings of Fact, Conclusions of Law, and Desist and Refrain Order under the authority of
 Section 10086 of the Code.

Whenever acts referred to below are attributed to HABOUD, those acts are alleged to
have been done by HABOUD, acting by himself, or by and/or through one or more agents,
associates, affiliates, and/or co-conspirators, including, but not limited to WORLD.

FINDINGS OF FACT

7 1. WORLD is not now, and has never been, licensed by the Department in any
8 capacity. WORLD is registered as a domestic corporation with the Secretary of State for the
9 State of California. This license is currently suspended.

2. HABOUD is presently licensed by the Department as a real estate salesperson.
 HABOUD is also the chief executive officer and agent for service of process for WORLD.
 HABOUD is not now, nor has he ever been, licensed by the Department as a real estate broker.
 At the time of the transaction at issue, HABOUD was registered with the Department as having
 Production Mortgage Inc. as his employing broker.

15 Erika Garcia transaction

In approximately June 2008, Erika Garcia (Garcia) contacted HABOUD regarding
the possibility of obtaining a short sale or negotiating a loan modification for Garcia's property
located at 17490 Sultana Street, Hesperia, CA 92345 (property). HABOUD offered to conduct a
short sale for the property.

4. In furtherance of his plan to offer sale of real property, on or about June 26, 2008,
 HABOUD requested that Garcia sign a Residential Listing Agreement for Garcia's property.
 This Agreement named "Southern California Realty" as the broker. HABOUD was not
 employed by Southern California Realty at the time of this transaction.

5. HABOUD also requested Garcia write a \$1,700 check to WORLD. Garcia wrote this
 check on July 2, 2008 and it was cashed on July 7, 2008. WORLD was not HABOUD's
 employing broker at the time of this transaction.

6. No short sale or loan modification was ever obtained by WORLD or HABOUD for the Garcia's Property.

CONCLUSIONS OF LAW

4 7. Based on the findings of fact contained in paragraphs 1 through 6, HABOUD, 5 acting by himself, or by and/or through one or more agents, associates, affiliates, and/or co-6 conspirators, including, but not limited to WORLD, promised to sell real property, or to perform 7 services for a borrower in connection with a loan secured directly or collaterally by one or more 8 liens on real property, and charged, demanded or collected advance fees for the services to be 9 provided, which acts require a real estate broker license under Sections 10131(a) and 10131(d) of 10 the Code, during a period of time when WORLD and HABOUD were not licensed by the Department as real estate brokers, in violation of Section 10130 of the Code.

DESIST AND REFRAIN ORDER

Based upon the FINDINGS OF FACT and CONCLUSIONS OF LAW stated herein, it is hereby ordered that WORLD FINANCIAL INVESTMENTS CORP and MICHAEL HABOUD, whether doing business under their own names, or any other names, ARE HEREBY ORDERED to immediately desist and refrain from performing any acts within the State of California for which a real estate broker license is required. In particular each of them is ORDERED TO DESIST AND REFRAIN from:
