1	FINDINGS OF FACT
2	1. At no time herein mentioned, has LATINO INVESTMENTS, LLC been
3	licensed by the Department of Real Estate of the State of California ("Department") as a real
4	estate broker or salesperson:
5	2. A limited liability company may not perform acts which require a real estate
6	license.
7	3. The Department does not issue real estate broker licenses to limited liability
8	companies.
9	4. During a period of time from the last three years to the present, LATINO
10	INVESTMENTS, LLC engaged in the business of, acted in the capacity of, advertised or
11	assumed to act as a real estate broker in the State of California, for another or others,
12	including, but not necessarily limited to, Eusebio and Elena Corral, within the meaning of
13	Code Section 10131 for or in expectation of compensation. LATINO INVESTMENTS,
14	LLC's activities included, but were not necessarily limited to, soliciting borrowers or
15	negotiating loans or performing services for borrowers in connection with loans secured by
16	liens on real property. In or around April of 2007, LATINO INVESTMENTS, LLC
17	performed services for borrowers Eusebio and Elena Corral in connection with a loan secured
18	directly by liens on real property located at 16808 Wing Lane, La Puente, California 91744
19	("Wing Lane property")
20	5. Escrow closed on the Wing Lane property transaction on April 12, 2007.
21	LATINO INVESTMENTS, LLC received \$5,787.50 as a loan origination fee and \$7,275 in
22	Yield Spread Premiums from escrow. LATINO INVESTMENTS, LLC received \$11,756.25 in
23	funds from escrow for the Wing Lane property transaction.
24	6. LATINO INVESTMENTS, LLC's acts as described in Paragraphs 4 and 5,
25	above, are acts requiring a real estate license under the provisions of Code Section 10131(d).
26	CONCLUSIONS OF LAW
27	1. Based on the findings of fact contained in Paragraphs 1 through 6, above,
