The Commissioner (Commissioner) of the California

Department of Real Estate (Department) caused an investigation to
be made of the activities of TAMMY L. LOPEZ dba Lopez Leasing.

Based on that investigation, the Commissioner has determined that
you have engaged in, are engaging in, or are attempting to engage
in, acts or practices constituting violations of the California

Business and Professions Code (Code), including violating Code

Section 10130 by engaging in the business of, acting in the
capacity of, and/or advertising or assuming to act as, a real
estate broker in the State of California within the meaning of
Code Section 10131(b) (soliciting renters and owners and
negotiating rental agreements on real property) and Section

10131.2 (advance fee handling). Furthermore, based on the

investigation, the Commissioner hereby issues the following Findings of Fact, Conclusions of Law, and Desist and Refrain Order under the authority of Section 10086 of the Code.

Whenever acts referred to below are attributed to TAMMY L. LOPEZ or "you" those acts are alleged to have been done by acting by yourself, or by and/or through one or more agents, associates, affiliates, and/or co-conspirators.

FINDINGS OF FACT

- 1. You are not now and have never been licensed by the Department of Real Estate of the State of California (hereinafter "Department") as a real estate broker.
- 2. During 2008 through 2009, for or in expectation of compensation, you solicited renters or owners and negotiated rental agreements on real property.
- 3. In approximately May, 2008, you solicited Kiziana Jean-Louis to rent property located at 5042 Denny Ave. #1, North Hollywood, California. Thereafter, you collected a \$500 advance fee deposit from Jean-Louis.
- 4. During 2009, for or in expectation of compensation, you solicited potential renters of real property through the Craiglist website.

CONCLUSIONS OF LAW

5. Based on the findings of fact contained in paragraphs 1 through 4, your acts, acting by yourself, or by and/or through one or more agents, associates, affiliates, and/or co-conspirators, solicited renters and owners and negotiated rental agreements on real property which acts require a real

estate broker license under Section 10131(b) of the Code, during a period of time when you were not licensed by the Department as a real estate broker, in violation of Section 10130 of the Code.

DESIST AND REFRAN ORDER

Based on the Findings of Fact and Conclusions of Law stated herein, you, TAMMY L. LOPEZ dba Lopez Leasing, whether doing business under your own names, or any other names or fictitious names, ARE HEREBY ORDERED to immediately desist and refrain from performing any acts within the State of California for which a real estate broker license is required unless or until you obtain a real estate broker license from the Department. In particular, you are ordered to desist and refrain from soliciting renters and owners and negotiating rental agreements for real property.
