DECISION

This Decision is being issued in accordance with the provisions of Section 11520 of the Government Code, on evidence of compliance with Section 11505 of the Government Code and pursuant to the Order of Default filed on August 22, 2011 and the findings of fact set forth herein are based on one or more of the following: (1) Respondents' express admissions; (2) affidavits; and (3) other evidence.

FINDINGS OF FACT

.1.

On September 20, 2010, Robin Trujillo made the Accusation in her official capacity as a Deputy Real Estate Commissioner of the State of California. The Accusation, Statement to Respondent, and Notice of Defense were mailed by certified mail, return receipt requested, to the last known mailing addresses on file with the Department of VALENCIA HOME LOAN'S SERVICES CORP ("VALENCIA"), FIRST CALIFORNIA REALTY GROUP INC ("FIRST"), and CESAR CARRASQUILLA ("CARRASQUILLA") on December 13, 2010. The mailings sent to VALENCIA were returned

to sender with no forwarding address. The certified mail packets sent to FIRST and CARRASQUILLA were received on December 14, 2010. No response has been received from any of the Respondents to date.

On August 22, 2011, no Notice of Defense having been filed herein within the time prescribed by Section 11506 of the Government Code, VALENCIA's, FIRST's and CARRASQUILLA's defaults were entered herein.

2.

VALENCIA presently has license rights under the Real Estate Law, Part 1 of Division 4 of the California Business and Professions Code ("Code") as a corporate real estate broker. On August 15, 2009, VALENCIA's license expired. However, the Department holds jurisdiction over the lapsed license, pursuant to Code Section 10103.

3.

FIRST is presently licensed and/or has license rights under the Real Estate Law as a corporate real estate broker. FIRST was initially licensed on August 16, 2005.

4.

CARRASQUILLA presently has license rights under the Real Estate Law as a real estate broker. On September 20, 2010, CARRASQUILLA's license expired. However, the Department holds jurisdiction over the lapsed license, pursuant to Code Section 10103. CARRASQUILLA was the designed officer of VALENCIA from June 29, 2009 until its license expired. CARRASQUILLA is presently the designated officer of FIRST.

5.

VALENCIA's corporation license is currently suspended by the Secretary of State for the State of California.

6.

FIRST's corporation license is currently suspended by the Secretary of State for the State of California.

DETERMINATION OF ISSUES

1.

The conduct, acts and/or omissions of <u>VALENCIA</u> and <u>FIRST</u>, as set forth above, is in violation of Section 2742 of Title 10, Chapter 6, California Code of Regulations, and provides cause for the suspension or revocation of the licenses and license rights of VALENCIA and FIRST pursuant to Code Sections 10177(d), 10177(g) and 10177(f).

2.

The conduct, acts and/or omissions of <u>CARRASOUILLA</u>, as alleged above, is in violation of Code Section 10159.2 and subjects his real estate license and license rights to suspension or revocation pursuant to Code Sections $\underline{10177(d)}$ and/or $\underline{10177(g)}$.

3.

The standard of proof applied was clear and convincing proof to a reasonable certainty.

ORDER

The licenses and license rights VALENCIA HOME LOAN'S SERVICES CORP, FIRST CALIFORNIA REALTY GROUP INC and CESAR CARRASQUILLA under the provisions of Part I of Division 4 of the Business and Professions Code are revoked.

2.

VALENCIA HOME LOAN'S SERVICES CORP ("VALENCIA")

presently has license rights under the Real Estate Law, Part 1

of Division 4 of the California Business and Professions Code
("Code") as a corporate real estate broker. On August 15,

2009, VALENCIA's license expired. Pursuant to Business and

Professions Code Section 10201, VALENCIA retains renewal rights
for two years. The Department of Real Estate holds
jurisdiction over the lapsed license, pursuant to Business and

Professions Code Section 10103.

3.

FIRST CALIFORNIA REALTY GROUP INC ("FIRST") is presently licensed and/or has license rights under the Real Estate Law, as a corporate real estate broker. FIRST was initially licensed as a corporate real estate broker on August 16, 2005.

4.

CESAR CARRASQUILLA ("CARRASQUILLA") is presently licensed and/or has license rights under the Real Estate Law, as a real estate broker. He was the designated officer of VALENCIA from June 29, 2007 until VALENCIA's licensed expired on August 15, 2009. CARRASQUILLA is also presently the designated officer of FIRST.

5.

Respondent VALENCIA's corporation license is currently suspended by the Secretary of State for the State of California.

6.

Respondent FIRST's corporation license is currently suspended by the Secretary of State for the State of California.

7.

The conduct of Respondents VALENCIA and FIRST, as alleged above, is in violation of Section 2742 of Title 10, Chapter 6, California Code of Regulations, and subjects their real estate licenses and license rights to suspension or revocation pursuant to Code Sections 10177(d), 10177(g) and/or 10177(f).

8.

The conduct, acts or omissions of Respondent CARRASQUILLA, as alleged above, is in violation of Code Section 10159.2, and subjects his real estate license and license rights to suspension or revocation pursuant to Code Sections 10177(d) and/or 10177(g).
