20	(M. LUA) and JUAN LUA (J. LUA). Based on that investigation, the Commissioner has
21	determined that MULTISERVICIOS, ALLIED, M. LUA and J. LUA have engaged in, are
22	engaging in, or are attempting to engage in, acts or practices constituting violations of the
23	California Business and Professions Code (Code), including the business of, acting in the
24	capacity of, and/or advertising or assuming to act as, real estate brokers in the State of California
25	within the meaning of Section 10131(a) (soliciting the purchase of real property) and Section
26	10131(d) (soliciting borrowers in connection with loans secured by real property) of the Code.
27	Furthermore, based on the investigation, the Commissioner hereby issues the following Findings - 1 -

1	of Fact, Conclusions of Law, and Desist and Refrain Order under the authority of Section 10086
2	of the Code.
3	Whenever acts referred to below are attributed to MULTISERVICIOS, ALLIED,
4	M. LUA or J. LUA, those acts are alleged to have been done by MULTISERVICIOS ALLIED,
5	M. LUA or J. LUA, acting by themselves, or by and/or through one or more agents, associates,
6	affiliates, and/or co-conspirators.
7	FINDINGS OF FACT
8	1. MULTISERVICIOS, ALLIED, M. LUA and J. LUA are not now, and have
9	never been, licensed by the Department in any capacity.
10	2. In or about September 2009, MULTISERVICIOS and ALLIED placed an
11	advertisement in which they claimed to specialize in loans and residential real estate closings.
12	The advertisement also offered to locate homes for purchase by potential clients.
13	3. In response to the advertisement, Natividad G. contacted
14	MULTISERVICIOS regarding the purchase of a home, in or about September 2009.
15	M. LUA and J. LUA offered to assist Natividad G. in the purchase of a home.
16	CONCLUSIONS OF LAW
17	4. Based on the findings of fact contained in paragraphs 1 through 3,
18	MULTISERVICIOS, ALLIED, M. LUA and J. LUA acting by themselves, or by and/or through
19	one or more agents, associates, affiliates, and/or co-conspirators, solicited purchasers of real
20	property and borrowers for loans secured by real property, which acts require a real estate
21	broker license under Sections 10131(a) and 10131(d) of the Code, during a period of time when
22	MULTISERVICIOS ALLIED, M. LUA and J. LUA were not licensed by the Department as
23	real estate brokers, in violation of Section 10130 of the Code.
24	DESIST AND REFRAIN ORDER
25	Based upon the FINDINGS OF FACT and CONCLUSIONS OF LAW stated
26	herein, it is hereby ordered that MULTISERVICIOS MARCY, ALLIED GROUP, MARICELA
27	BEARGARD-LUA and JUAN LUA, whether doing business under their own names, or any

1	other names, ARE HEREBY ORDERED to immediately desist and refrain from performing any
2	acts within the State of California for which a real estate broker license is required, unless or

11	public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by imprisonment in the county jail for a term not to exceed six months, or by both fine and
12	imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars (\$60,000)."
