) STIPULATION AND

15 I, CHRISTINE RAE BULLARD, Respondent herein, do hereby affirm that I have applied to the  
16 Department of Real Estate for a real estate salesperson license and that to the best of my knowledge I have  
17 satisfied all of the statutory requirements for the issuance of the license, including the payment of the fee  
18 therefor.

19 I acknowledge that I have received and read the Statement of Issues and the Statement to Respondent  
20 filed by the Department of Real Estate on April 25, 2011, in connection with my application for a real estate  
21 salesperson license. I understand that the Real Estate Commissioner may hold a hearing on this Statement of  
22 Issues for the purpose of requiring further proof of my honesty and truthfulness and to prove other  
23 allegations therein, or that he may in his discretion waive the hearing and grant me a restricted real estate  
24 salesperson license based upon this Stipulation and Waiver. I also understand that by filing the Statement of  
25 Issues in this matter the Real Estate Commissioner is shifting the burden to me to make a satisfactory  
26 showing that I meet all the requirements for issuance of a real estate salesperson license. I further  
27 understand that by entering into this stipulation and waiver I will be stipulating that the Real Estate

1 Commissioner has found that I have failed to make such a showing, thereby justifying the denial of the  
2 issuance to me of an unrestricted real estate salesperson license.

3 I hereby admit that the allegations of the Statement of Issues filed against me are true and correct and  
4 request that the Real Estate Commissioner in his discretion issue a restricted real estate salesperson license  
5 to me under the authority of Section 10156.5 of the Business and Professions Code.

6 I am aware that by signing this Stipulation and Waiver, I am waiving my right to a hearing and the  
7 opportunity to present evidence at the hearing to establish my rehabilitation in order to obtain an  
8 unrestricted real estate salesperson license if this Stipulation and Waiver is accepted by the Real Estate  
9 Commissioner. However, I am not waiving my right to a hearing and to further proceedings to obtain a  
10 restricted or unrestricted license if this Stipulation and Waiver is not accepted by the Commissioner.

11 I further understand that the following conditions, limitations, and restrictions will attach to a  
12 restricted license issued by the Department of Real Estate pursuant hereto:

- 13 1. The license shall not confer any property right in the privileges to be exercised including the  
14 right of renewal, and the Real Estate Commissioner may by appropriate order suspend the right  
15 to exercise any privileges granted under this restricted license in the event of:
  - 16 a. Respondent's conviction (including a plea of nolo contendere) of a crime which bears a  
17 substantial relationship to Respondent's fitness or capacity as a real estate licensee; or
  - 18 b. The receipt of evidence that Respondent has violated provisions of the California Real  
19 Estate Law, the Subdivided Lands Law, Regulations of the Real Estate Commissioner or  
20 conditions attaching to this restricted license.
- 21 2. I shall not be eligible to apply for the issuance of an unrestricted real estate license nor the  
22 removal of any of the conditions, limitations, or restrictions attaching to the restricted license  
23 until two years have elapsed from the date of issuance of the restricted license to Respondent.
- 24 3. With the application for license, or with the application for transfer to a new employing broker, I  
25 shall submit a statement signed by the prospective employing broker on a form approved by the  
26 Department of Real Estate wherein the employing broker shall certify as follows:

a. That broker has read the Statement of Issues which is the basis for the issuance of the restricted license; and

b. That broker will carefully review all transaction documents prepared by the restricted licensee and otherwise exercise close supervision over the licensee's performance of acts for which a license is required.

4. Respondent shall notify the Commissioner in writing within 72 hours of any arrest by sending a certified letter to the Commissioner at the Department of Real Estate, Post Office Box 187000, Sacramento, CA 95818-7000. The letter shall set forth the date of Respondent's arrest, the crime for which Respondent was arrested and the name and address of the arresting law enforcement agency. Respondent's failure to timely file written notice shall constitute an independent violation of the terms of the restricted license and shall be grounds for the suspension or revocation of that license.

Respondent can signify acceptance and approval of the terms and conditions of this Stipulation and Waiver by faxing a copy of the signature page, as actually signed by Respondent, to the Department at fax number (213) 576-6917. Respondent agrees, acknowledges and understands that by electronically sending to the Department a fax copy of his actual signature as it appears on the Stipulation and Waiver, that receipt of the faxed copy by the Department shall be as binding on Respondent as if the Department had received the original signed Stipulation and Waiver.


I have read the Statement of Issues filed herein and the foregoing Stipulation and Waiver signed by Respondent. I am satisfied that the hearing for the purpose of requiring further proof as to the honesty and truthfulness of Respondent need not be called and that it will not be inimical to the public interest to issue a restricted real estate salesperson license to Respondent.

Therefore, IT IS HEREBY ORDERED that a restricted real estate salesperson license be issued to Respondent CHRISTINE RAE BULLARD if Respondent has otherwise fulfilled all of the statutory requirements for licensure. The restricted license shall be limited, conditioned, and restricted as specified in the foregoing Stipulation and Waiver.

This Order is effective immediately.

15 The Complainant, Robin Trujillo, a Deputy Real Estate  
16 Commissioner of the State of California, acting in her official  
17 capacity, for Statement of Issues against CHRISTINE RAE BULLARD  
18 aka Christine Rae Mushetto ("Respondent") alleges as follows:

19 1.

20 On or about October 14, 2010, Respondent made  
21 application to the Department of Real Estate of the State of  
22 California for a real estate salesperson license.

23  
24 (CRIMINAL CONVICTION)

25 2.

26 On or about June 16, 1987, in the Municipal Court of  
27 Glendale Judicial District, County of Los Angeles, California,

1 Case No. 87M02750, Respondent was convicted of violating  
2 California Penal Code Section 484(a) (theft), a misdemeanor.  
3 Said crime bears a substantial relationship to the  
4 qualifications, functions, or duties of a real estate licensee  
5 under Section 2910, Title 10, Chapter 6, California Code of  
6 Regulations.

7 3.

8 The crime of which Respondent was convicted as alleged  
9 in Paragraph 2, above, constitutes cause for denial of  
10 Respondent's application for a real estate license under  
11 California Business and Professions Code Sections 475(a)(2),  
12 480(a), and 10177(b).

13  
14 (FAILURE TO REVEAL CONVICTION)

15 4.

16 In response to Part D - Question 1 of her license  
17 application, to wit: "HAVE YOU EVER BEEN CONVICTED OF A  
18 MISDEMEANOR OR FELONY? CONVICTIONS EXPUNGED UNDER PENAL CODE  
19 SECTION 1203.4 MUST BE DISCLOSED. HOWEVER, YOU MAY OMIT MINOR  
20 TRAFFIC CITATIONS WHICH DO NOT CONSTITUTE A MISDEMEANOR OR  
21 FELONY OFFENSE," Respondent answered "No," and failed to reveal  
22 the conviction described in Paragraph 2, above.

23 5.

24 Respondent's failure to reveal the conviction in her  
25 license application constitutes knowingly making a false  
26 statement of material fact required to be revealed in said  
27 application, which is grounds for denial of the issuance of a

1 license under California Business and Professions Code Sections  
2 475(a)(1), 480(c), and 10177(a).

3           These proceedings are brought under the provisions of  
4 Section 10100, Division 4 of the Business and Professions Code  
5 of the State of California and Sections 11500 through 11528 of  
6 the California Government Code.

7           WHEREFORE, the Complainant prays that the above-  
8 entitled matter be set for hearing and, upon proof of the  
9 charges contained herein, that the Commissioner refuse to  
10 authorize the issuance of, and deny the issuance of, a real  
11 estate salesperson license to Respondent, CHRISTINE RAE BULLARD,  
12 and for such other and further relief as may be proper under  
13 other applicable provisions of law.
