The Commissioner ("Commissioner") of the California

Department of Real Estate caused an investigation to be made of
the activities of JAIME OLIVA ("OLIVA"). Based on that
investigation, the Commissioner has determined that OLIVA has
engaged in, is engaging in, or is attempting to engage in, acts
or practices constituting violations of the California Business
and Professions Code, including the business of, acting in the
capacity of, and/or advertising or assuming to act as, a real
estate broker in the State of California within the meaning of
California Business and Professions Code Sections 10131(d)
(soliciting borrowers for or collecting payments in connection
with loans secured by liens on real property) and 10131.2

(advanced fees). Furthermore, based on the investigation, the Commissioner hereby issues the following Findings of Fact, Conclusions of Law, and Desist and Refrain Order under the authority of California Business and Professions Code Section 10086.

FINDINGS OF FACT

From at least March 15, 2005 to the present,
 OLIVA has not been licensed with the Department of Real Estate as a real estate broker.

2. In or about June 2008, OLIVA solicited payment from Maria M. for the possible refinance of property at 6103 Melvil Street, Culver City, CA 90232. Maria M. gave three checks to OLIVA dated June 18, 2008, June 18, 2008, and July 12, 2008 paid to the order of OLIVA in the amount of \$600.00, \$700.00, and \$500.00, respectively. Maria M. also gave a fourth check dated June 18, 2008 to OLIVA that was paid to the order of Jonathon Hu for \$800.00 for appraisals. However, this fourth check was deposited into the same account as the three checks paid to the order of OLIVA.

CONCLUSIONS OF LAW

3. Based on the findings of fact contained in Paragraphs 1 through 2, OLIVA, acting by himself, or by and/or through one or more agents, associates, affiliates, and/or coconspirators, solicited and collected payments for the refinancing of real property, which acts require a real estate broker license under California Business and Professions Code

Sections 10131(d) and 10131.2, during a period of time when OLIVA was not licensed by the Department of Real Estate as a real estate broker, in violation of California Business and 3 4 Professions Code Section 10130. 5 DESIST AND REFRAIN ORDER Based upon the FINDINGS OF FACT and CONCLUSIONS OF б LAW stated herein, it is hereby ordered that JAIME OLIVA, 7 8 whether doing business under his/her own name, or any other 9 names. IS HEREBY ORDERED to immediately desist and refrain from 10 performing any acts within the State of California for which a real estate broker license is required, unless or until JAIME 11 12 OLIVA is properly licensed by the Department of Real Estate. 13 14 Real Estate Commissioner 15 16 17 California Business and Professions Code Section 10139 18 provides that "Any person acting as a real estate broker or real estate salesperson without a license or who advertises using 19 words indicating that he or she is a real estate broker without 20 being so licensed shall be guilty of a public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by 21 imprisonment in the county jail for a term not to exceed six months, or by both fine and imprisonment; or if a corporation, 22 be punished by a fine not exceeding sixty thousand dollars (\$60,000)." 23 cc: JAIME OLIVA 24 411 Walnut Haven Drive West Covina, CA 91790 26 8300 Sixth Avenue 27 Hesperia, CA 92345
