RUBEN A. DIAZ (Respondent) was present at hearing and represented himself.

Oral and documentary evidence was received and the matter was submitted for decision on October 12, 2011.

On March 1, 2012, the Administrative Law Judge rendered a Proposed Decision, which I declined to adopt as my Decision herein. Pursuant to Section 11517(c) of the Government Code of the State of California, Respondent was served with notice of my determination not to adopt the Proposed Decision of the Administrative Law Judge along with a copy of said Proposed Decision. Respondent was notified that I would decide the case upon the record, the transcript of proceedings held on October 12, 2011, and upon any written argument offered by Respondent and Complainants.

I have given careful consideration to the record in this case including the transcript of the proceedings of October 12, 2011.

The Factual Findings and Conclusions of Law in Proposed Decision dated March 1, 2012, of the Administrative Law Judge of the Office of Administrative Hearings are hereby adopted.

The Order shall be as follows:

ORDER

- All licenses and license rights of Respondent FAST LOANS INC., under the Real Estate Law are revoked.
- All licenses and license rights of Respondent REMAX EMPIRE, INC.
 under the Real Estate Law are revoked.
- All licenses and license rights of Respondent RUBEN A. DIAZ under the Real Estate Law are revoked.

The right to reinstatement of a revoked real estate license is controlled by Section 11522 of the Government Code.

This Decision shall become effective at 12 o'clock noon on NOV 1 3 2012. IT IS SO ORDERED ____ Real Estate Commissioner Chief Counsel
