ORDER ACCEPTING VOLUNTARY SURRENDER OF REAL ESTATE LICENSE

On October 19, 2011, an Accusation was filed in this matter against Respondent
CALLIX CADMEAD RICHARDSON.

On July 17, 2012, Respondent petitioned the Commissioner to voluntarily
surrender his real estate broker license rights pursuant to Section 10100.2 of the Business and
Professions Code.

IT IS HEREBY ORDERED that Respondent CALLIX CADMEAD
RICHARDSON's petition for voluntary surrender of his real estate broker license rights is

1 accepted as of the effective date of this Order as set forth below, based upon the understanding

My name is CALLIX CADMEAD RICHARDSON and I am currently licensed as a real estate broker and/or have license rights with respect to said license.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the Government Code), I wish to voluntarily surrender my real estate license rights issued by the Department of Real Estate ("Department"), pursuant to Business and Professions Code Section 10100.2.

1 I understand that by so voluntarily surrendering my license rights, I may be
2 relicensed as a broker or as a salesperson by petitioning for reinstatement pursuant to Section
3 11522 of the Government Code. I also understand that by so voluntarily surrendering my
4 license(s), I agree to the following:

5 1. The filing of this Declaration shall be deemed as my petition for voluntary
6 surrender.

8 2. It shall also be deemed to be an understanding and agreement by me that I
9 waive all rights I have to require the Commissioner to prove the allegations contained in the
10 Accusation ("Accusation") filed in this matter at a hearing held in accordance with the
11 provisions of the Administrative Procedure Act (Government Code Sections 11400 et seq.), and
12 that I also waive other rights afforded to me in connection with the hearing such as the right to
13 discovery, the right to present evidence in defense of the allegations in the Accusation and the
14 right to cross-examine witnesses.

15 3. I further agree that upon acceptance by the Commissioner, as evidenced by an
16 appropriate order, all affidavits and all relevant evidence obtained by the Department in this
17 matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation
18 filed in the Department Case No. H-37604 LA, with respect to me may be considered by the
19 Department to be true and correct for the purpose of deciding whether to grant relicensure or
20 reinstatement pursuant to Government Code Section 11522.

21 4. This Declaration is not an admission by CALLIX CADMEAD
22 RICHARDSON as to the allegations in the Accusation. This Declaration is made for the
23 purpose of reaching a resolution of allegations contained in the DRE Case number H-37604
24 LA, and is expressly limited to this proceeding and any other proceeding or case in which the

1 Department of Real Estate is a party and shall not otherwise be admissible or relied upon by any
2 third parties for any purpose.

3 5. I further agree to pay the Commissioner's reasonable cost of the audit
4 (\$4,133.08) of Universal Consulting Services Inc. which led to this action. In calculating the
5 amount of the Commissioner's reasonable cost, the Commissioner may use the estimated
6 average hourly salary for all persons performing audits of real estate brokers, and shall include
7 an allocation for travel time to and from the auditor's place of work. I will pay such cost within
8 60 days of receiving an invoice from the Commissioner detailing the activities performed
9 during the audit and the amount of time spent performing those activities. I am aware that if I
10 petition for reinstatement in the future, that payment of the audit costs will be a condition of
11 reinstatement.

12 6. I freely and voluntarily surrender all my licenses and license rights under the
13 Real Estate Law.

14 I declare under penalty of perjury under the laws of the State of California that
15 the above is true and correct and that this declaration was executed on July 17, 2012
16 2012, at Agoura Hills California.
