Pursuant to Business and Professions Code Section 10100.2, I wish to voluntarily surrender my real estate broker license and C & M FINANCIAL, INC.'s real estate corporate broker license issued by the Department.

I understand that by so voluntarily surrendering these licenses, that C & M FINANCIAL, INC. and I may be relicensed as a corporation, broker or as a salesperson only by petitioning for reinstatement pursuant to Section 11522 of the Government Code.

I agree also that the filing of this Declaration shall be deemed to be our petition to voluntarily surrender these real estate licenses and shall also be deemed to be an understanding and agreement by us that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all other relevant statements, declarations and evidence obtained during the course of the investigation prior to the Commissioner's acceptance may be considered by the Department to be true and correct for the purpose of deciding whether or not to grant reinstatement of our licenses pursuant to the provisions of Government Code Section 11522. This understanding and agreement is made without admitting or denying the truth or contents of the aforementioned documents.

I declare under penalty of perjury under the laws of the State of California that the above is true and correct and that I freely and voluntarily surrender my broker license and C & M FINANCIAL, INC.'s corporate broker license and all license rights attached thereto.
