22	that each of them engaged in or is engaging in acts or practices

the meaning of Code Section 10131(d) (soliciting borrowers or 1 lenders or negotiating loans) and/or Code Section 10131.2 2 (advance fee handling). Based on the findings of that 3 investigation, as set forth below, the Commissioner hereby issues 4 the following Findings of Fact and Desist and Refrain Order 5 pursuant to Section 10086 of the Code. 6 7 FINDINGS OF FACT 8 1. WALDROFF is presently licensed and/or has license 9 rights under the Real Estate Law (Part 1 of Division 4 of the 10 Code) as a real estate broker. 11 2. Since on or about June 22, 2009, BARKER has been 12 licensed and/or has license rights under the Real Estate Law as 13 a real estate salesperson. Prior to June 22, 2009, BARKER was 14 not licensed by the Department in any capacity. 15 3. At no time herein mentioned herein has CAL-PRO 16 EQUITIES, INC., doing business as Keep Your Home Today ("KEEP 17 YOUR HOME"), been licensed by the Department in any capacity. 18 KEEP YOUR HOME, WALDROFF and BARKER engaged in the 4. 19 business of claiming, demanding, charging, receiving, collecting 20 or contracting for the collection of an advance fee, as defined 21 by Code Section 10026, including but not limited to the 22 activities described in Paragraph 6, below. 23 24 5. WALDROFF failed to submit the advance fee 25 agreement referred to in Paragraph 6, below, to the Commissioner 26 ten days before using it. 27 At the times set forth below KEEP YOUR HOME, 6. - 2 -

WALDROFF and BARKER engaged in the business of, acted in the capacity of, or advertised a real estate loan service and advance fee brokerage offering to perform and performing solicitation, negotiation and modification of loans secured by liens on real property for compensation or in expectation of compensation and for fees collected in advance including, but not limited to, the following:

a. On or about November 27, 2008, Linda C. paid KEEP
YOUR HOME an advance fee of \$2995. The advance fee was collected
by WALDROFF pursuant to the provisions of an agreement
pertaining to loan solicitation, negotiation, and modification
services to be provided by KEEP YOUR HOME with respect to a loan
secured by the real property at 28387 Crosby Street, Murrieta,
California 92563.

CONCLUSIONS OF LAW

7. The activities described in Paragraph 6, above, require a real estate license under Section 10131(d) and Section 19 10131.2 of the Code.

8. Based on the information contained in Paragraphs 20 2,3, 4 and 6 above, BARKER and KEEP YOUR HOME performed and/or 21 participated in loan solicitation, negotiation and modification 22 23 activities which require a real estate broker license under the 24 provisions of Code Sections 10131(d) and 10131.2 during a period 25 of time when neither of them was licensed by the Department as a 26 real estate broker nor employed as a real estate salesperson by 27 the broker on whose behalf the activities were performed in

violation of Section 10130 of the Code.

9. Based on the information contained in Paragraphs 4, 5 and 6, above, KEEP YOUR HOME, WALDROFF and BARKER collected fees pursuant to an agreement which constitutes an advance fee agreement within the meaning of Code Section 10085 and Section 2970 of the Regulations.

DESIST AND REFRAIN ORDER

10 1. IT IS HEREBY ORDERED that STEVEN CARL WALDROFF, 11 whether doing business under the name KEEP YOUR HOME, or any 12 other names, or any fictitious name:

A. Immediately desist and refrain from charging, demanding, claiming, collecting and/or receiving advance fees, as that term is defined in Section 10026 of the Code, in any form, and under any conditions, with respect to the performance of loan modification or any other form of mortgage loan forbearance services in connection with loans on residential property containing four or fewer dwelling units (Code Section 10085.6).

B. Immediately desist and refrain from charging, demanding, claiming, collecting and/or receiving advance fees, as that term is defined in Section 10026 of the Code, for any of the other real estate related services offered to others, unless and until STEVEN CARL WALDROFF demonstrates and provides evidence satisfactory to the Commissioner that he:

(i) has an advance fee agreement which has been

(ii) has placed all previously collected advance fees
into a trust account for that purpose and is in compliance with

11 IT IS HEREBY ORDERED that CAL-PRO EQUITIES, INC., 2. 12 and JAIME DAN BARKER, whether doing business under their own 13 names, or any other names, or any fictitious name, including 14 Keep Your Home Today, ARE HEREBY ORDERED to immediately DESIST 15 AND REFRAIN from performing any acts within the State of 16 California for which a real estate broker license is required. 17 In particular each of them is ORDERED TO DESIST AND REFRAIN 18 from: 19

A. charging, demanding, claiming, collecting and/or receiving advance fees, as that term is defined in Section 10026 of the Code, in any form, and under any conditions, with respect to the performance of loan modifications or any other form of mortgage loan forbearance service in connection with loans on residential property containing four or fewer dwelling units (Code Section 10085.6); and

B. charging, demanding, claiming, collecting and/or
