19 and alleges as follows:

20 1.

21 The Complainant, Robin Trujillo, a Deputy Real Estate
22 Commissioner of the State of California, makes this Accusation
23 in her official capacity.

24 2.

25 Respondent is presently licensed and/or has license
26 rights under the Real Estate Law, Part 1 of Division 4 of the
27 California Business and Professions Code ("Code") as a corporate

1 real estate broker. Respondent was originally licensed as a
2 corporate real estate broker on or about July 16, 2008.

3 3.

4 On or about May 3, 2010, the Franchise Tax Board of
5 the State of California suspended Respondent's powers, rights
6 and privileges pursuant to the provisions of the California
7 Revenue and Taxation Code, and the entity's powers, rights and
8 privileges remain forfeited to date.

9 4.

10 The conduct of Respondent, as alleged above, is in
11 violation of Section 2742 of Title 10, Chapter 6, California
12 Code of Regulations, and subjects its real estate licenses and
13 license rights to suspension or revocation pursuant to Code
14 Section 10177(d), 10177(g) and/or 10177(f).


