The Commissioner (Commissioner) of the California Department of Real Estate (Department) caused an investigation to be made of the activities of METRO INVESTMENTS & PROPERTY SERVICES; TERRA-BELLA PROPERTY MANAGEMENT; TERRA BELLA PROPERTY SERVICES; METRO SERENDIB CORPORATION; THILINA "TONY" BALASURIYA; DARSHI BALASURIYA; and ROHAN BALASURIYA, doing business as Metro Investments & Property Services, Terra-Bella Property Services, Metro Serendib Corportation and/or any other unknown fictitious business name(s). Based on the investigation, the Commissioner has determined that TERRA-BELLA PROPERTY MANAGEMENT,

TERRA BELLA PROPERTY SERVICES, METRO SERENDIB CORPORATION, THILINA "TONY" BALASURIYA, DARSHI BALASURIYA and ROHAN BALASURIYA have engaged in, are engaging in, or are attempting to engage in, acts or practices constituting violations of the California Business and Professions Code (Code) and/or Title 10, Chapter 6, California Code of Regulations (Regulations), including the business of, acting in the capacity of, and/or advertising or assuming to act as a real estate broker in the State of California within the meaning of Section 10131(b) (offer to lease, solicit listings of places for rent, solicit prospective tenants, negotiate the sale, purchase or exchange of leases on real property, or collect rents from real property or improvements thereon) of the Code. Furthermore, based on the investigation, the Commissioner hereby issues the following Findings of Fact, Conclusions of Law, and Desist and Refrain Order under the authority of Section 10086 of the Code.

Whenever acts referred to below are attributed to METRO INVESTMENTS & PROPERTY SERVICES, TERRA-BELLA PROPERTY MANAGEMENT, TERRA BELLA PROPERTY SERVICES or METRO SERENDIB CORPORATION, those acts are alleged to have been done by THILINA "TONY" BALASURIYA, DARSHI BALASURIYA and ROHAN BALASURIYA, acting by themselves, or by and/or through one or more agents, associates, affiliates, and/or co-conspirators, and using the names METRO INVESTMENTS & PROPERTY SERVICES, TERRA-BELLA PROPERTY MANAGEMENT, TERRA BELLA PROPERTY SERVICES, METRO SERENDIB CORPORATION, or other names or fictitious names unknown at this time.

FINDINGS OF FACT

 At no time herein mentioned has METRO INVESTMENTS & PROPERTY SERVICES been licensed by the Department in any capacity.

BALASURIYA, DARSHI BALASURIYA and ROHAN BALASURIYA, while using the fictitious business names METRO INVESTMENTS & PROPERTY SERVICES, TERRABELLA PROPERTY MANAGEMENT, TERRA BELLA PROPERTY SERVICES, METRO SERENDIB CORPORATION and any other fictitious business name(s) unknown at this time, have been offering to lease, soliciting listings of places for rent, soliciting prospective tenants, negotiating the sale, purchase or exchange of leases on real property, or collecting rents from real property or improvements thereon) within the meaning of Code Section 10131(b).

11. THILINA "TONY" BALASURIYA, DARSHI BALASURIYA and ROHAN BALASURIYA began operating METRO INVESTMENTS & PROPERTY SERVICES, TERRA-BELLA PROPERTY MANAGEMENT, and TERRA BELLA PROPERTY SERVICES and offered property management services to others within the meaning of Code Section 10131(b) following the suspension of METRO SERENDIB CORPORATION's corporate broker license on April 28, 2005.

- 12. From January, 1993 through August 31, 2009, Francisco S. worked as a handyman for METRO INVESTMENTS & PROPERTY SERVICES and/or METRO SERENDIB CORPORATION, which conducted property management services for others.
- 13. TERRA-BELLA PROPERTY MANAGEMENT and TERRA BELLA PROPERTY SERVICES continue to advertise property management services to others within the meaning of Code Section 10131(b) through various sources including, but not limited to, print publications and on the internet at www.terrabellamanagement.com.

CONCLUSIONS OF LAW

14. Based on the findings of fact contained in paragraphs 1 through 13, THILINA "TONY" BALASURIYA, DARSHI BALASURIYA and ROHAN BALASURIYA, acting by themselves, or by and/or through one or more agents, associates, affiliates, and/or co-conspirators, and using the names METRO INVESTMENTS & PROPERTY SERVICES.

TERRA-BELLA PROPERTY MANAGEMENT, TERRA BELLA PROPERTY SERVICES,
METRO SERENDIB CORPORATION or other names or fictitious names unknown at this
time, offered to lease, solicited listings of places for rent, solicited prospective tenants,
negotiated the sale, purchase or exchange of leases on real property, or collected rents from real
property or improvements thereon, which requires a real estate license under Code Section
10131(b), during a period of time when METRO INVESTMENTS & PROPERTY
SERVICES, TERRA-BELLA PROPERTY MANAGEMENT, TERRA BELLA PROPERTY
SERVICES, METRO SERENDIB CORPORATION, THILINA "TONY" BALASURIYA,
DARSHI BALASURIYA and ROHAN BALASURIYA were not licensed by the Department
in any capacity, in violation of Section 10130 of the Code.

DESIST AND REFRAIN ORDER

Based on the Findings of Fact and Conclusions of Law stated herein, METRO INVESTMENTS & PROPERTY SERVICES, TERRA-BELLA PROPERTY MANAGEMENT, TERRA BELLA PROPERTY SERVICES, METRO SERENDIB CORPORATION, THILINA "TONY" BALASURIYA, DARSHI BALASURIYA and ROHAN BALASURIYA, doing business under your own names or any other names or fictitious names, ARE HEREBY ORDERED to immediately desist and refrain from performing any acts within the State of California for which a real estate broker license is required, and in particular, offering to lease, soliciting listings of places for rent, soliciting prospective tenants, negotiating the sale, purchase or exchange of leases on real property, or collecting rents from real property or improvements thereon, unless and until you obtain a real estate broker license issued by the Department.

Notice: Business and Professions Code Section 10139 provides that "Any person acting as a real estate broker or real estate salesperson without a license or who advertises using words indicating that he or she is a real estate broker without being so licensed shall be guilty of a public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by imprisonment in the county jail for a term not to exceed six months, or by both fine and imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars (\$60,000)."
