16 The Complainant, Robin Trujillo, a Deputy Real Estate  
17 Commissioner of the State of California, for cause of Accusation  
18 against MATTHEW PATRICK WADE ("Respondent"), alleges as follows:

19 1.

20 The Complainant, Robin Trujillo, a Deputy Real Estate  
21 Commissioner of the State of California, makes this Accusation  
22 in her official capacity.

23 2.

24 Respondent is presently licensed and/or has license  
25 rights under the Real Estate Law, Part 1 of Division 4 of the  
26 California Business and Professions Code ("Code"), as a real  
27 estate broker.

1 3.

2 On or about March 8, 2010, in the Superior Court of  
3 the State of California, Los Angeles County, in Case No.  
4 9PY08204, Respondent pled *nolo contendere* and was convicted for  
5 three counts of violating Penal Code 647(A) (disorderly conduct:  
6 solicit lewd act), a misdemeanor. Respondent was sentenced to  
7 36 months probation, 60 days in jail (or perform 45 days of Cal  
8 Trans in lieu of jail), and ordered to pay fines. In addition,  
9 Respondent was ordered to stay 100 yards away from North  
10 Hollywood High School

11 4.

12 This conviction, by its facts and circumstances, bears  
13 a substantial relationship under Section 2910, Title 10, Chapter  
14 6, California Code of Regulations to the qualifications,  
15 functions or duties of a real estate licensee.

16 5.

17 The crime of which Respondent was convicted  
18 constitutes cause under Sections 490 and 10177(b) of the Code  
19 for the suspension or revocation of the license and license  
20 rights of Respondent under the Real Estate Law.
