20	Respondent filed by the Department of Real Estate on April 10, 2012, in connection with my
21	application for a real estate broker license. I understand that the Real Estate Commissioner may
22	hold a hearing on this Statement of Issues for the purpose of requiring further proof of my honesty
23	and truthfulness and to prove other allegations therein, or that he may in his discretion waive the
24	hearing and grant me a restricted real estate broker license based upon this Stipulation and Waiver. I
25	also understand that by filing the Statement of Issues in this matter the Real Estate Commissioner is
26	shifting the burden to me to make a satisfactory showing that I meet all the requirements for
27	issuance of a real estate broker license. I further understand that by entering into this stipulation

and waiver I will be stipulating that the Real Estate Commissioner has found that I have failed to 1 make such a showing, thereby justifying the denial of the issuance to me of an unrestricted real 2 estate broker license. 3

I hereby admit that the allegations of the Statement of Issues filed against me are true and 4 correct and request that the Real Estate Commissioner in his discretion issue a restricted real estate 5 broker license to me under the authority of Section 10156.5 of the Business and Professions Code. 6 I am aware that by signing this Stipulation and Waiver, and if this Stipulation and Waiver is 7 accepted by the Real Estate Commissioner, I am waiving my right to a hearing and the opportunity 8 to present evidence at the hearing to establish my rehabilitation in order to obtain an unrestricted 9 real estate broker license.
