. 7	1. HCI has been licensed by the Department as a corporate real estate broker since
8	January 28, 2010.
9	2. BABILA has been licensed by the Department as a real estate broker since
10	February 1, 2007. From May 17, 2010 to October 28, 2010, BABILA was licensed as the
11	designated officer of HCI.
12	3. On or about July 25, 2010, HCI, conducted a third party escrow for
13	purchaser Peter W., wherein HCI was not performing acts in the course of, or incidental to, a real
14	estate transaction in which HCI was an agent or party to the transaction and in which HCI was
15	performing acts for which a real estate license is required.
16	4. On or about August 25, 2010, HCI and BABILA conducted a third party
17	escrow for the purchasers Rick and Paulina C., wherein HCI and BABILA were not performing
. 18	acts in the course of, or incidental to, a real estate transaction in which HCI and BABILA were
19	agents or parties to the transaction and in which HCI and BABILA were performing acts for
20	which a real estate license is required.
