20 as follows:

22 On or about November 4, 2011, Respondent made
23 application to the Department of Real Estate of the State of
24 California for a real estate broker license.

1 (CRIMINAL CONVICTIONS)

3 On or about June 4, 2001, in the Circuit Court of
4 State of Oregon for Multnomah County, Case No. 01-06-34480,
5 Respondent was convicted of two counts of assault in the third
6 degree, both felonies, and misdemeanor driving under the
7 influence of intoxicants. Said crimes bear a substantial
8 relationship to the qualifications, functions, or duties of a
9 real estate licensee under Section 2910, Title 10, Chapter 6,
10 California Code of Regulations.

12 The crimes of which Respondent was convicted as
13 alleged herein constitute cause for denial of Respondent's
14 application for a real estate license under California Business
15 and Professions Code Sections 475(a)(2), 480(a), and 10177(b).

16 These proceedings are brought under the provisions of
17 Section 10100, Division 4 of the Business and Professions Code
18 of the State of California and Sections 11500 through 11528 of
19 the California Government Code.


