ORDER SUSPENDING REAL ESTATE LICENSE

TO: JARED A. STANSFIELD

On October 16, 2013, all licenses and license rights
of Respondent JARED A. STANSFIELD, License ID 01897820, were to
be suspended on the terms, conditions and restrictions set forth
in the Bureau of Real Estate Commissioner's Decision in Case No.
H-38277 LA. This Order became effective on October 16, 2013.

1 Among the terms and conditions of the Order,
2 Respondent was required to: (A) provide proof satisfactory of
3 payment of restitution in the amount of \$250.00 to Adhaar Lall
4 and \$250 to Roger Schindler prior to the effective date of the
5 Decision; (B) take and pass the Professional Responsibility
6 Examination within six (6) months from the effective date of the
7 Decision; and (C) provide satisfactory proof of completion of 45
8 hours of approved continuing education courses within nine (9)
9 months from the effective date of the Decision. The
10 Commissioner has determined that Respondent has failed to
11 satisfy condition (A).

12 NOW, THEREFORE, IT IS ORDERED under authority of the
13 Order issued in this matter that the real estate officer license
14 heretofore issued to Respondent and the exercise of any
15 privileges thereunder is hereby suspended until such time as
16 Respondent provides proof satisfactory to the Bureau of Real
17 Estate ("Bureau") of compliance with the "condition" referred to
18 above, or pending final determination made after hearing (see
19 "Hearing Rights" set forth below).

20 IT IS FURTHER ORDERED that all license certificates
21 and identification cards issued by the Bureau which are in the
22 possession of Respondent be immediately surrendered by personal
23 delivery or by mailing in the enclosed, self-addressed envelope



1 HEARING RIGHTS: You have the right to a hearing to
2 contest the Commissioner's determination that you are in
3 violation of the Order issued in this matter. If you desire a
4 hearing, you must submit a written request. The request may be
5 in any form, as long as it is in writing and indicates that you
6 want a hearing. Unless a written request for a hearing, signed
7 by or on behalf of you, is delivered or mailed to the Bureau of
8 Real Estate at 320 W. 4th Street, Room 350, Los Angeles,
9 California 90013, within 20 days after the date that this Order
10 was mailed to or served on you, the Bureau will not be obligated
11 or required to provide you with a hearing.

12 This Order shall be effective immediately.
