The Complainant, Maria Suarez, acting in her official capacity as a Deputy Real Estate Commissioner of the State of California, makes this Accusation against PAUL MICHAEL BALLESTEROS and ANA MARIA ALVAREZ.

II

PAUL MICHAEL BALLESTEROS ("BALLESTEROS") is presently licensed and/or has license rights under the Real Estate Law

(Part 1 of Division 4 of the Business and Professions Code, hereinafter "Code") as real estate salesperson. BALLESTEROS was first licensed by the Department of Real Estate for the State of California ("Department") on or about September 19, 1990. At all relevant times herein, BALLESTEROS was licensed under the employ of broker NA Nationwide Mortgage. BALLESTEROS is not now, and has never been, licensed by Department as employed by ANA MARIA ALVAREZ.

III

ANA MARIA ALVAREZ("ALVAREZ") is presently licensed and/or has license rights under the Real Estate Law as a broker. ALVAREZ was first licensed by the Department as a broker on or about October 21, 1993. Since May 3, 1994, ALVARES has had "A-Plus Realty" licensed as a fictitious business name with the Department.

ΙV

On or about May 5, 2009, BALLESTEROS signed a Residential Listing Agreement and a Short Sale Listing Addendum for property located at 14139 Dartmouth Court, Fontana, CA. Both of these documents listed BALLESTEROS as working on behalf of A-Plus Realty.

V

On or about November 5, 2009, ALVAREZ paid a commission of \$7,200 to BALLESTEROS for the short sale of the property located at 14139 Dartmouth Court, Fontana, CA.

Under Code Section 10137, it is unlawful for any broker to employ or compensate a salesperson who is not licensed under the broker, for performing acts requiring a real estate license. Likewise, under Code Section 10137, no salesperson shall be employed by or accept compensation from any person other that the broker under whom he is at the time licensed.
