

DECLARATION

My name is ABDUL KHADER SYED. I am a licensed real estate salesperson. I am representing myself in this matter.

I have been informed by the Department of Real Estate that I am the subject of an investigation of possible violations of the Real Estate Law (Sections 10000 et seq., of the Business and Professions Code) and Regulations of the Real Estate Commissioner (Title 10, Chapter 6, of the California Code of Regulations) which could result in the filing of an Accusation to revoke or suspend my real estate license; and pursuant to Business and Professions Code Section 10100.2, I wish to

1 voluntarily surrender my real estate salesperson license issued
2 by the Department.

3 I understand that by so voluntarily surrendering my
4 license, I may be relicensed as a broker or salesperson only by
5 petitioning for reinstatement pursuant to Section 11522 of the
6 Government Code.

7 I agree also that the filing of this Declaration shall
8 be deemed to be my petition to voluntarily surrender my real
9 estate license and shall also be deemed to be an understanding
10 and agreement by me that upon acceptance by the Commissioner, as
11 evidenced by an appropriate order, all affidavits and all other
12 relevant statements, declarations and evidence obtained during
13 the course of the investigation prior to the Commissioner's
14 acceptance may be considered by the Department to be true and
15 correct for the purpose of deciding whether or not to grant
16 reinstatement of my license pursuant to the provisions of
17 Government Code Section 11522. This understanding and agreement
18 is made without admitting or denying the truth or contents of the
19 aforementioned documents.

20 I declare under penalty of perjury under the laws of
21 the State of California that the above is true and correct and
22 that I freely and voluntarily surrender my license and all
23 license rights attached thereto.
