12	3. Based on the findings of fact contained in paragraphs 1 and 2, ESCALANTE solicited		
13	buyers and performed services for those buyers which requires a real estate license under		
14	Section 10131(a) of the Code, during a period of time when ESCALANTE was not licensed by		
15	the Department in any capacity, in violation of Section 10130 of the Code.		
16	DESIST AND REFRAIN ORDER
