

DECLARATION

My name is SEAN PATRICK GOODWIN and I am currently licensed as a real estate broker and/or have license rights with respect to said license.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the Government Code), I wish to voluntarily surrender my real estate license and license rights issued by the Department of Real Estate ("Department"), pursuant to Business and Professions Code Section 10100.2.

I understand that by so voluntarily surrendering my license rights, I may be relicensed as a broker or as a salesperson by petitioning for reinstatement pursuant to Section 11522 of the

1 Government Code. I also understand that by so voluntarily surrendering my license(s), I agree  
2 to the following:

3 1. The filing of this Declaration shall be deemed as my petition for voluntary surrender.

4 2. It shall also be deemed to be an understanding and agreement by me that I waive all  
5 rights I have to require the Commissioner to prove the allegations contained in the Accusation  
6 (“Accusation”) filed in this matter at a hearing held in accordance with the provisions of the  
7 Administrative Procedure Act (Government Code Sections 11400 et seq.), and that I also waive  
8 other rights afforded to me in connection with the hearing such as the right to discovery, the  
9 right to present evidence in defense of the allegations in the Accusation and the right to cross-  
10 examine witnesses.  
11

12 3. I further agree that upon acceptance by the Commissioner, as evidenced by an  
13 appropriate order, all affidavits and all relevant evidence obtained by the Department in this  
14 matter prior to the Commissioner’s acceptance, and all allegations contained in the Accusation  
15 filed in the Department Case No. H-38672 LA, with respect to me may be considered by the  
16 Department when deciding whether to grant relicensure or reinstatement pursuant to  
17 Government Code Section 11522.

19 4. This Declaration is made for the purpose of reaching a resolution of allegations  
20 contained in the DRE Case number H-38672 LA, and is expressly limited to this proceeding  
21 and any other proceeding or case in which the Department of Real Estate is a party and shall not  
22 otherwise be admissible or relied upon by any third parties for any purpose.

24 5. I freely and voluntarily surrender all my licenses and license rights under the Real  
25 Estate Law.
