rights under the Real Estate Law (Part 1 of Division 4 of the

Business and Professions Code, hereinafter "Code"), as a real estate salesperson.

3.

On or about March 3, 2010, Respondent executed and submitted to the Department as part of Respondent's Salesperson Renewal Application a Continuing Education Course Verification ("CE Verification") form representing that he had taken and completed each of nine separate courses listed on his CE Verification form.

4.

In reliance on Respondent's representation as set forth in Paragraph 3, above, on or about March 8, 2010, the Department processed Respondent's renewal application and issued to him a real estate salesperson license with an effective date of March 28, 2010.

5.

Thereafter, as a result of an investigation undertaken by the Department, it was determined that Respondent had failed to actually take and complete four of the courses listed on the CE Verification form as described in Paragraph 3, above. Specifically, Respondent failed to take and complete the following courses:

- a. C1 101: Financial Analysis for Commercial Real Estate;
 - b. Trust Fund Handling;
 - c. Agency Relationships, Duties & Disclosures; and

d. Ethics, Professional Conduct, and the Real Estate Professional.

6.

Respondent's representation, as alleged in Paragraph 3, above, was false and fraudulent and made with the intent to fraudulently induce the Department to issue a renewal real estate salesperson license to Respondent despite Respondent's failure to have completed the necessary continuing education coursework entitling Respondent to the renewal of his license.

7.

The conduct, acts and/or omissions of Respondent, as described herein above, constitute knowingly making a false statement of material fact in an application for a renewal of a real estate license, the making of a substantial misrepresentation, and/or fraud or dishonest dealing, and are cause for the suspension or revocation of all real estate licenses and license rights of Respondent ALAN KEITH ONTIVEROS under the provisions of Code Sections 498, 10177(a), 10176(a), 10176(i), 10177(d), 10177(g) and/or 10177(j).

California Business and Professions Code Section 10106 provides, in pertinent part, that in any order issued in resolution of a disciplinary proceeding before the department, the Commissioner may request the administrative law judge to direct a licensee found to have committed a violation of this part to pay a sum not to exceed the reasonable costs of investigation and enforcement of the case.

WHEREFORE, Complainant prays that a hearing be conducted on the allegations of this Accusation and that upon proof thereof, a decision be rendered imposing disciplinary action against all licenses and/or license rights under the Real Estate Law (Part 1 of Division 4 of the California Business and Professions Code) of Respondent ALAN KEITH ONTIVEROS, for the cost of investigation and enforcement as permitted by law, and for such other and further relief as may be proper under other provisions of law.
