A C C U S A T I O N

16 The Complainant, Robin Trujillo, a Deputy Real Estate
17 Commissioner of the State of California, for cause of Accusation
18 against MTL INVESTMENT ENTERPRISES INC ("Respondent"), is
19 informed and alleges as follows:

20 1.

21 The Complainant, Robin Trujillo, a Deputy Real Estate
22 Commissioner of the State of California, makes this Accusation
23 in her official capacity.

24 2.

25 Respondent is presently licensed and/or has license
26 rights under the Real Estate Law, Part 1 of Division 4 of the
27 California Business and Professions Code ("Code") as a corporate

1 real estate broker. Respondent was originally licensed as a
2 corporate real estate broker on or about April 20, 2010.

3 3.

4 On or about May 29, 2012, Respondent filed a Domestic
5 Stock Corporation Certificate of Dissolution with the Secretary
6 of State for the State of California. Effective on May 29,
7 2012, Respondent's powers, rights and privileges ceased under
8 the Secretary of State for the State of California.

9 4.

10 The conduct of Respondent, as alleged above, is in
11 violation of Section 2742 of Title 10, Chapter 6, California
12 Code of Regulations, and subjects its real estate licenses and
13 license rights to suspension or revocation pursuant to Code
14 Section 10177(d), 10177(g) and/or 10177(f).

15 5.

16 Code Section 10106, provides, in pertinent part, that
17 in any order issued in resolution of a disciplinary proceeding
18 before the Department, the Commissioner may request the
19 administrative law judge to direct a licensee found to have
20 committed a violation of this part to pay a sum not to exceed
21 the reasonable costs of the investigation and enforcement of the
22 case.


