ACCUSATION

The Complainant, Veronica Kilpatrick, a Deputy Real Estate Commissioner of the State of California, for cause of Accusation against CAKE REALTY INC and DOROTHY LOUISE CAKE, individually, and as designated officer of Cake Realty Inc, alleges as follows:

1.

The Complainant, Veronica Kilpatrick, acting in her official capacity as a Deputy Real Estate Commissioner of the State of California, makes this Accusation against CAKE REALTY INC and DOROTHY LOUISE CAKE.

All references to the "Code" are to the California
Business and Professions Code and all references to "Regulations"
are to Title 10, Chapter 6, California Code of Regulations.

LICENSE HISTORY

3.

- A. At all times mentioned, CAKE REALTY INC ("CRI") and DOROTHY LOUISE CAKE ("CAKE") were licensed or had license rights issued by the Bureau of Real Estate ("Bureau") as real estate brokers.
- B. At all times mentioned, CRI was licensed by the Bureau as a corporate real estate broker by and through CAKE, as the designated officer and broker responsible, pursuant to Code Section 10159.2 for supervising the activities requiring a real estate license conducted on behalf of CRI by CRI's officers, agents and employees, including CAKE. CRI was originally licensed on April 24, 2009.
- C. At all times mentioned, DOROTHY LOUISE CAKE ("CAKE") was licensed or had license rights issued by the Bureau as a real estate broker. On May 18, 2000, CAKE was originally licensed as a real estate broker. On April 24, 2009, CAKE was licensed as the designated officer of CRI.

BROKERAGE

CAKE REALTY INC

4.

At all times mentioned, in the City of Temecula, County of Riverside, CRI and CAKE acted as real estate brokers,

conducting licensed activities within the meaning of Code

Sections 10131(a) and 10131(b) by selling or offering to sell

real property and leasing real property for others.

AUDIT

CAKE REALTY INC

5.

On December 9, 2011, the Bureau (then called "The Department of Real Estate") completed an audit examination of the books and records of CRI pertaining to the loan activities described in Paragraph 4 which require a real estate license. The audit examination covered a period of time beginning on September 1, 2009 to September 30, 2011. The audit examination revealed violations of the Code and the Regulations as set forth in the following paragraphs, and as more fully discussed in Audit Reports SD100094 and SD110014 and the exhibits and workpapers attached to said audit reports.

VIOLATIONS OF THE REAL ESTATE LAW

6.

In the course of activities described in Paragraph 4 above, and during the examination period described in Paragraph 5, Respondents CRI and CAKE acted in violation of the Code and the Regulations in that:

(a) CRI's trust account had a shortage of \$8,706.54, as of September 30, 2011, without the written consent of every principal who was an owner of the funds in the account, in violation of Code Section 10145 and Regulation 2832.1.

- (b) CRI did not maintain a monthly reconciliation of all the separate records to the control record of all trust funds received and disbursed, in violation of Code Section 10145 and Regulation 2831.2.
- (c) The bank account CRI used for trust funds was not designated as a trust account during the audit period, in violation of Code Section 10145 and Regulation 2832.
- (d) CRI allowed an unlicensed individual without fidelity bond coverage to be a signer on the bank account used to handle trust funds, in violation of Code Section 10145 and Regulation 2834.

7.

The conduct of Respondents CRI and CAKE, described in Paragraph 7, above, violated the Code and the Regulations as set forth below:

The foregoing violations constitute cause for the suspension or revocation of the real estate licenses and license rights of CRI and CAKE, under the provisions of Code Sections 10177(d) and/or 10177(g).

SUPERVISION AND COMPLIANCE

8.

The overall conduct of Respondent CAKE constitutes a failure on her part, as officer designated by a corporate broker licensee, to exercise the reasonable supervision and control over the licensed activities of CRI as required by Code Section 10159.2, and to keep CRI in compliance with the Real Estate Law, and is cause for the suspension or revocation of the real estate license and license rights of CAKE pursuant to the provisions of Code Sections 10177(d), 10177(g) and 10177(h).

9.

Code Section 10106, provides, in pertinent part, that in any order issued in resolution of a disciplinary proceeding before the Bureau, the Commissioner may request the administrative law judge to direct a licensee found to have committed a violation of this part to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case.
