16 17	caused an investigation to be made of the activities of JAMES MICHAEL MURDOCK and LA

19	has determined that JAMES MICHAEL MURDOCK and LA CUMBRE MANAGEMENT			
. 20	COMPANY INC. and have engaged in, are engaging in, or are attempting to engage in, acts or			
21	practices constituting violations of the California Business and Professions Code ("Code"),			
22	including acting in the capacity of, advertising and/or assuming to act as a real estate broker in			
23	the State of California within the meaning of Code Section 10131(b) (leasing or renting, or			
24 25	offering to lease or rent, soliciting prospective tenants, and collecting rents on behalf of others in			
26	expectation of compensation.) Based on that investigation, the Commissioner hereby issues the			
27	following Findings of Fact, Conclusions of Law, and Desist and Refrain Order under the

Whenever acts referred to below are attributed to JAMES MICHAEL 2 MURDOCK and/or to LA CUMBRE MANGEMENT COMPANY INC., those acts are alleged 3 4 to have been done by that individual or entity acting by themselves, or by and/or through one or 5 more officers, employees, or agents, including but not limited to the individuals herein named. 6 **FINDINGS OF FACT** 7 Individuals and Entities 8 1. JAMES MICHAEL MURDOCK ("MURDOCK") is not presently licensed 9 by the Department of Real Estate ("Department") as a real estate salesperson or real estate 10 broker. Between 1988 and 1992, MURDOCK was licensed as the designated broker-officer of 11 LA CUMBRE MANAGEMENT COMPANY INC. MURDOCK's broker-officer license 12 expired on or about April 6, 1992, and has never been reinstated. 13 2. LA CUMBRE MANAGEMENT COMPANY INC. ("LA CUMBRE") is a 14 California corporation. MURDOCK is the president of LA CUMBRE. Effective on or about 15 November 16, 2012, LA CUMBRE's corporate status was suspended by the California 16 Secretary of State. 17 3. Between 1988 and 1992, LA CUMBRE was licensed by the Department as a 18 corporate real estate broker. MURDOCK was LA CUMBRE's broker-officer designated 19 pursuant to Code Section 10159.2 to be responsible for ensuring LA CUMBRE's compliance 20 with the Real Estate Law. LA CUMBRE's corporate real estate broker license expired on or 21 about April 6, 1992, and has never been reinstated. 22 4. At times relevant herein, LA CUMBRE operated out of office located at 100 23 N. Hope Ave, Suite 1, Santa Barbara, CA 93110-1686. 24 Unlicensed Property Management Activity 25 5. Beginning on or before January 10, 2005, and continuing through the present 26 time, LA CUMBRE and MURDOCK advertised and solicited tenants through print and 27 electronic media, offering to provide property management services for landlords and rentals for - 2 -

1	tenants for a fee. In addition, LA CUMBRE and MURDOCK actually performed property
2	management activities for owners of rental property for a fee. The property management
3	activities performed by LA CUMBRE and MURDOCK have included acting on behalf of the
4	owners of Arroyo Mobilehome Park, negotiating leases with tenants, collecting rents, making
5	disbursements of rents and maintaining property in exchange for a monthly fee. In addition, LA
6	CUMBRE advertised its property management services in local publications.
7	6. At the time that MURDOCK and LA CUMBRE engaged in property
8	management activities, they were not licensed by the Department in any capacity.
9	CONCLUSIONS OF LAW
10	1. The collection of rents, solicitation and negotiation of leases and management
11	of rental property on behalf of property owners for a fee are acts for which a real estate license
12	is required, as set forth in Business and Professions Code Section 10131(b).
13	2. As described in the Findings of Fact set forth above, MURDOCK and LA
14	CUMBRE performed property management services which require a real estate license during a
15	period of time when neither MURDOCK nor LA CUMBRE were licensed by the Department in
16	any capacity.
17	3. The conduct of JAMES MICHAEL MURDOCK and of LA CUMBRE
18	MANGEMENT COMPANY INC is in violation of Business and Professions Code Section
19	10130.
