ORDER SUSPENDING RESTRICTED REAL ESTATE LICENSE

On March 16, 2015, a Stipulation and Agreement was filed by the Bureau of Real Estate regarding the Accusation against RONALD CLINTON DOUGLAS, in Case No. H-39059 LA. Among the terms and conditions of this Stipulation and Agreement, which became effective on April 15, 2015, was an order that:

“Respondent RONALD CLINTON DOUGLAS shall within nine (9) months from the effective date of this Decision, present evidence satisfactory to the Real Estate commissioner that Respondent has, since the most recent issuance of an original or renewal real estate license, taken and successfully completed the continuing education requirements of Article 2.5 of Chapter 3 of the Real Estate Law for renewal of a real estate license. If Respondent fails to satisfy this condition, the Commissioner may order the suspension of the license until Respondent presents such evidence. The Commissioner shall afford Respondent the opportunity for a hearing pursuant to the Administrative Procedure Act to present such evidence.”

1 The Commissioner has determined that, as of February 16, 2016,  
2 Respondent has failed to satisfy this condition.

3 NOW, THEREFORE, IT IS ORDERED that the real estate broker license  
4 heretofore issued to Respondent RONALD CLINTON DOUGLAS and the exercise of any  
5 privileges thereunder are hereby suspended until such time as Respondent provides proof  
6 satisfactory to the Bureau of compliance with the condition(s) referred to above.

7 IT IS FURTHER ORDERED that all license certificates and identification  
8 cards issued by Bureau which are in the possession of Respondent be immediately  
9 surrendered by personal delivery or by mailing in the enclosed, self-addressed envelope to:
