Respondent was convicted of violating California Penal Code section 192(b) (involuntary manslaughter), a felony. This crime is substantially related to the qualifications, functions, or duties of a real estate licensee under Section 2910, Title 10, Chapter 6, California Code of Regulations.

The crime of which Respondent was convicted as alleged herein constitutes cause for denial of Respondent's application for a real estate license under California Business and Professions Code sections 475(a)(2), 480(a), and 10177(b).

In aggravation, on or about December 2, 2009, the California Department of Insurance issued an Order of Summary Denial denying Respondent's application for a license to act as a life-only agent and as an accident and health agent. The denial was based upon Respondent's felony conviction described in Paragraph 2, above.

These proceedings are brought under the provisions of Section 10100, Division 4 of the Business and Professions Code of the State of California and Sections 11500 through 11528 of the California Government Code.
