On or about December 16, 2004, Respondent was convicted in the Superior 6 Court of California, County of Los Angeles, Case No. BA275271, for violation of California 7 Health & Safety Code Section 11351.5 (possession for sale of cocaine base), a felony. 8 Respondent was placed on three (3) years probation with credit, one hundred twenty (120) days 9 in jail with sixty-one (61) days of credit, and ordered to pay restitution. Additionally, 10 Respondent was ordered to register as a narcotics offender when released from custody. This 11 conviction bears a substantial relationship under Section 2910, Title 10, Chapter 6, of the 12 California Code of Regulations, to the qualifications, functions or duties of a real estate 13 licensee. 14

On or about August 11, 2006, Respondent was found in violation of probation and sentenced to serve an additional thirty (30) days in jail with four (4) days of credit.

On or about September 14, 2006, Respondent's probation was revoked.
On or about December 20, 2006, Respondent was found in violation of
probation, sentenced to three (3) years in prison with credit, and ordered to pay restitution and
register as a narcotics offender.
