#### FIRST CAUSE FOR DENIAL

### (CRIMINAL CONVICTIONS)

3.

On or about April 3, 2012, Respondent pled guilty and was convicted in the Superior Court of California, County of Los Angeles, Case No. BA377154, for violation of the California Penal Code Section 550(b)(1) (Insurance Fraud), a misdemeanor. Respondent was placed on two years of summary probation, and ordered to pay restitution, fines and fees. Additionally, Respondent was ordered to perform 180 hours of community service.

4.

On or about October 28, 2013, Respondent pled nolo contendere and was convicted in the Superior Court of California, County of Los Angeles, Case No. 3PS10873, for violation of the California Penal Code Section 415(2) (Disturbing The Peace), a misdemeanor. Respondent was placed on three years of summary probation, and ordered to pay restitution, fines and fees. Additionally, Respondent was ordered to complete a 26 week anger management program and a 26 week parenting program.

5.

The convictions described in Paragraphs 3 and 4 bear a substantial relationship under Section 2910, Title 10, Chapter 6, California Code of Regulations to the qualifications, functions or duties of a real estate licensee.

The crimes of which Respondent was convicted, as described in Paragraphs 3 and 4 above, constitute cause for denial of Respondent's application for a real estate license under Business and Professions Code Sections 475(a)(2)-(3), 480(a)(1)-(2), and 10177(b).

#### SECOND CAUSE FOR DENIAL

## (FAILURE TO REVEAL CHARGES ON LICENSE APPLICATION)

7.

In response to Question 26, under the Background Information section of her license application, to wit, "ARE THERE CRIMINAL CHARGES PENDING AGAINST YOU AT THIS TIME," Respondent answered "NO," and failed to disclose the pending criminal charges described in Paragraph 4, above.

Respondent's failure to reveal the criminal charges pending, as set forth in Paragraph 4 above, in her license application constitutes an attempt to procure a real estate license by fraud, misrepresentation, or deceit, or by making a false statement of material fact required to be revealed in said application, which is grounds for denial of the issuance of a license under California Business and Professions Code Sections 475(a)(1), 480(d), and 10177(a).

These proceedings are brought under the provisions of Section 10100,

Division 4 of the Business and Professions Code of the State of California and Sections 11500 through 11528 of the California Government Code.
