MND's California Corporate Number is C3663567. 9

3. JOSE MARQUEZ is not now, and has never been licensed by the Bureau in any 10 capacity. 11

These acts, which require a real estate broker license under Code Section 18 10131(d), were performed during a period of time when MARQUEZ was not licensed by the 19 Bureau as a real estate broker, a violation of Code Section 10130. 20
