## (CEASE AND DESIST ORDER)

3.

On or about February 12, 2014, in case no. CR-57463, the California Department of Consumer Affairs—Bureau of Electronic and Appliance Repair, Home Furnishings, and Thermal Insulator ("BEAR") issued and served an Order of Abatement on Respondent for his violation of California Business and Professions Code section 9840 (acting as a service dealer without proper registration). This Order of Abatement ordered Respondent to cease and desist from operating as a service dealer. Specifically, Respondent offered and provided cell phone repair services, and operated a cell phone repair store, DNZ Wireless, which is located at 2033 South Hacienda Blvd., Hacienda Heights, CA 91745. Respondent was given the opportunity to request a hearing, but did not do so. To date, Respondent continues act as a service dealer without proper registration.

4.

The allegations in Paragraph 3, above, constitute cause for suspension or revocation of Respondent's real estate license under California Business and Professions Code section 10177(f) and 10177(j).

## (FAILURE TO REVEAL CEASE AND DESIST ORDER)

5.

On or about September 1, 2015, Respondent filed a Salesperson Renewal Application. In response to Question 18 of his Salesperson Renewal Application, to wit: "WITHIN THE SIX-YEAR PERIOD PRIOR TO FILING THIS APPLICATION, HAVE YOU EVER BEEN ORDERED TO CEASE, DESIST[,] AND/OR REFRAIN FROM DOING AN ACT(S), OR FROM VIOLATING A LAW, RULE[,] OR REGULATION BY, OR CITED FOR A BREACH OF ETHICS OR UNPROFESSIONAL CONDUCT, BY AN ADMINISTRATIVE AGENCY OR PROFESSIONAL ASSOCIATION IN CALIFORNIA OR

1	ANY OTHER STATE?" Respondent answered, "No," and failed to reveal the Order of		
2	Abatement described in Paragraph 3, above.

4	Respondent's failure to reveal the Order of Abatement in his Salesperson		
5	Renewal Applications constitutes knowingly making a false statement of material fact required		
6	to be revealed in said application, which is grounds for revoking a license under California		
7	Business and Professions Code sections 475(a)(1), 480(d), and 10177(a).		
8	7.		
9	California Business and Professions Code section 10106 provides, in pertinent		
LO	part, that in any order issued in resolution of a disciplinary proceeding before the bureau, the		
11	Commissioner may request the administrative law judge to direct a licensee found to have		
12	committed a violation of this part to pay a sum not to exceed the reasonable costs of		
13	investigation and enforcement of the case.		
L4	WHEREFORE, Complainant prays that a hearing be conducted on the		
L5	allegations of this Accusation and that upon proof thereof, a decision be rendered imposing		
L6	disciplinary action against all licenses and/or license rights under the Real Estate Law (Part 1 of		
L7	Division 4 of the California Business and Professions Code) of Respondent UGUR KAREM		
18	ORAL for the cost of investigation and enforcement as permitted by law, and for such other and		
19	further relief as may be proper under applicable provisions of law.
