On or about December 10, 2013, Respondent while 5 performing acts requiring a real estate broker license received from Raul G. \$3,000 for deposit on commercial Lease Agreement 6 7 between Martin R. and Raul G. for the property located at 8104 8 Firestone Blvd., Downey, CA known as Maria's Mexican Restaurant 9 with the understanding that in the event that buyer or seller 10 decided to cancel escrow for any reason the deposit would be 100% 11 refunded.

6. On or about January 22, 2014, Respondent received
from Raul G. an additional \$4,000 as part of the deposit making
the total deposit \$7,000.

7. Respondent thereafter misappropriated the \$7,000
 deposit to his own use and benefit without the knowledge or
