I further agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits, and all relevant evidence obtained by the Bureau in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Bureau Case No. H-40134 LA, may be considered by the Bureau to be true and correct for the purpose of deciding whether to grant licensure, relicensure, and/or reinstatement pursuant to California Government Code section 11522 and/or a similar code section.
