25	Orange, Case No. 14NM09860, Respondent pled guilty to and was convicted for violation of
26	California Vehicle Code Section 20002(a) (hit and run), a misdemeanor. Respondent was

1	placed on probation for 3 years and ordered to complete 10 days of physical labor with the
2	California Department of Transportation in lieu of serving 10 days in jail. This conviction bears
3	a substantial relationship under Section 2910, Title 10, Chapter 6, California Code of
4	Regulations to the qualifications, functions or duties of a real estate licensee.

6	In aggravation, on or about May 2, 2013, in the Superior Court of California,
7	County of San Bernardino, Case No. TWV1300898, Respondent pled guilty to and was
8	convicted for violation of California Vehicle Code Section 23152(b) (driving with 0.08% or
9	more blood alcohol content), a misdemeanor. Respondent was placed on probation for 36
10	months and ordered to attend a 1 st Offender Alcohol Program for 4 months.

12	The crime of which Respondent was convicted, as alleged in Paragraph 2 above,
13	constitutes cause for denial of Respondent's application for a real estate license under California
14	Business and Professions Code Sections 475(a)(2), 480(a)(1), and 10177(b).

16	These proceedings are brought under the provisions of Section 10100, Division
17	4 of the Business and Professions Code of the State of California and Sections 11500 through
18	11528 of the California Government Code.
